OFFICE ORDER NO. 61 of 2026

In partial modification of Office Order No. 31 of 2025 dated 08.04.2025, and in pursuance of an administrative decision taken by the Competent Authority in the interest of efficient functioning and better administrative control, the Competent Authority ordered that Major Anutosh Singh, Assistant Director General of Shipping, shall henceforth look after the work relating to the Training Branch only, with immediate effect or until further orders.

2. The above decision has been taken with a view to streamlining the work distribution and ensuring focused attention towards the activities and responsibilities pertaining to the Training Branch. Accordingly, Major Anutosh Singh shall cease to look after the work of the Crew Branch with immediate effect.
3. Consequent upon the above, Major Anutosh Singh, Assistant Director General of Shipping, shall prepare a comprehensive handing-over report clearly indicating the status of all pending, ongoing, and time-bound matters pertaining to the Crew Branch. The report shall include details of files under process, court cases (if any), policy matters, correspondence pending at various levels, and any other critical issues requiring immediate attention. The said report shall be submitted to the concerned authority.
