



**Annex to letter No. F. No. 25-75011/5/2024-NT-DGS Date – 10.04.2026**

1. All statutory Certificates and Certificate of Class for vessels entered with **M/s. Islamic Protection & Indemnity Club, Dubai**, shall remain valid throughout the vessel's stay/transit in Indian waters.
2. Certificate of Entry in respect of ships entered with **M/s. Islamic Protection & Indemnity Club, Dubai**, shall remain valid throughout the vessels stay/transit in Indian waters.
3. The certificate of entry of vessels entered with **M/s. Islamic Protection & Indemnity Club, Dubai**, Club Hall be issued only by **M/s. Islamic Protection & Indemnity Club, Dubai**, and this cannot be delegated to any other entity.
4. Any changes to the Rules of **M/s. Islamic Protection & Indemnity Club, Dubai**, affecting the liability in terms of maritime claims shall be immediately communicated to the Directorate General of Shipping without any delay.
5. The annual audited financial statements and details of claims (if any) during the period of approval is to be submitted annually.
6. Any changes to the address of the local correspondent and maritime lawyers, if appointed, shall be immediately communicated to the Directorate General of Shipping without any delay.
7. The number of ships and gross tonnage [GT] of ships entered with the company shall be submitted annually.
8. The vessels entered with the **M/s. Islamic Protection & Indemnity Club, Dubai**, shall comply with the applicable legislation during the transit and stay in Indian waters.
9. During the validity of the approval, no adverse reports against the company are to be received.
10. In the event of assured becoming insolvent/ bankrupt or liquidated, **M/s. Islamic Protection & Indemnity Club, Dubai**, shall undertake to discharge their obligations even if insolvency/ liquidation or proceedings are reported to be in progress in any Competent Court.
11. **M/s. Islamic Protection & Indemnity Club, Dubai**, shall provide online verification system of Certificate of entry and blue cards issued by them with its validity.
