2. All candidates are hereby informed that applications for Eligibility Assessment and Seat Booking for all Engineering Grades shall be submitted only through the new Examination Portal: (<https://exams.dgma.gov.in/>)
3. All written exam candidates are hereby informed to reach the examination centre at least 45 minutes before commencement of the examination.

5. The examinees should not carry any bags, phone, smartwatch or any such electronic device inside the exam hall.
6. This is to notify all candidates appearing for the Engineering Grade Examinations under MMD Mumbai for the month of September 2026 session that the examination centre has been changed. will now be conducted at the following venue:

7. No candidate will be allowed to leave the examination hall before the examination is over.
8. The new examination portal uses the Bharatkosh payment gateway which enables all payment modes (UPI/Net banking/Credit/Debit card).
9. The candidates are advised to refrain from making multiple payments if the payment confirmation message is not received.
10. The candidates may attempt the payment again, only after receiving a 'failed transaction' receipt as shall be reflected in the portal.
11. All the candidates will have to maintain discipline inside the examination centre, protect furniture and the IT infrastructure. In case an examinee is found indulging in unfair means during the exam, action shall be taken as per Rule 72 of the MS(STCW) Rules, 2014.
